


# Types of Customs Documents and Express Parcels

## **Understanding Customs Documentation**

Customs documentation forms the foundation of legal international trade. These documents enable authorities to verify goods, calculate duties, and ensure regulatory compliance across borders.

Proper documentation prevents delays, reduces costs, and ensures smooth clearance through customs checkpoints worldwide.



### **Primary Customs Documents**



#### Import Declaration

Details goods entering the country, including exporter-importer information, product specifications, tariff classification, and declared value for duty calculation




#### **Export Declaration**

Provides information on goods leaving the country, subject to customs verification before authorising international dispatch



#### Commercial Invoice

Issued by seller to buyer, specifying pricing, quantities, and product details essential for import tax assessment



### **Essential Supporting Documentation**

1

#### **Packing List**

Displays quantity, weight, and packaging details of shipment contents for verification at customs checkpoints

2

#### Bill of Lading / Air Waybill

Critical document issued by carrier (sea/air) confirming receipt of goods from sender and commitment to transport to destination

3

#### Certificate of Origin

Verifies country of manufacture, essential for claiming preferential tariff treatment under FTA or ASEAN agreements

### Additional Required Documents

Import/Export Licences

Regulatory permits for controlled goods

Specialised Agency Approvals

Certifications from bodies such as Food and Drug Administration, Department of Livestock, or Energy Department

Power of Attorney

Authorisation for customs broker representation

Tax Receipt & Insurance Certificate

Proof of duty payment and cargo protection



### International Express Parcels

Express parcels refer to international shipment of items or documents through expedited courier systems such as DHL, FedEx, UPS, TNT, or EMS, utilising simplified customs procedures for rapid clearance of small-scale consignments.

#### **Documents**

Letters, contracts, quotations, invoices—typically duty-exempt unless commercial value exists

#### **Commercial Parcels**

Product samples or traded goods requiring customs inspection and tariff-based duty payment

#### Personal Items

Gifts or personal belongings potentially exempt from duties if value remains below threshold limits



### **Express Parcel Customs Process**

#### Pre-Arrival Data Submission

Courier service provider transmits shipment information to customs systems before arrival in destination country

#### **Duty Payment**

Electronic payment processing through e-Payment systems for applicable tariffs and taxes

#### **Customs Clearance**

Verification of documentation, declaration forms, and data accuracy by customs authorities

#### Final Delivery

Upon clearance completion, parcel dispatched to recipient at destination address

#### e-Customs System

Electronic platform for submitting customs declarations, streamlining documentation and reducing processing time



#### Courier Post System

Specialised customs system designed specifically for express parcel clearance procedures



#### Tracking System

Real-time monitoring capability for shipment status throughout the customs and delivery process
